DIRECT CREMATION - PLAN REQUESTED BY MOST FAMILIES AND MEMBERS _____ **\$1,748.00**

Our charge for a direct cremation (without ceremony) includes basic services of funeral director and staff, proportionate share of overhead costs; removal of remains within San Diego County to crematory; necessary authorizations; cremation in a state mandated cremation container; or given to the family in a durable container. Delivery of cremains to a local National Cemetery is included.

BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF OVERHEAD _____ **\$1199.00**

Our services include: planning the funeral; shelter of remains; preparing and filing of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery; crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs.
